**PETITION TO INTERVENE OF
PACIFIC NORTHWEST GENERATING COOPERATIVE**

Pursuant to the Federal Register notice, 87 Fed. Reg. 69,259 (November 18, 2022), regarding the Bonneville Power Administration (“BPA”) Fiscal Year 2024-2025 Proposed Power and Transmission Rate Adjustments Public Hearing and Opportunities for Public Review and Comment, and Section 1010.6 of BPA’s 2018 Rules of Procedure, Pacific Northwest Generating Cooperative d/b/a PNGC Power (“PNGC Power”) hereby petitions for leave to intervene as a party in the above-captioned proceeding.

PNGC Power is a cooperative corporation organized under the laws of the State of Oregon and a Joint Operating Entity pursuant to the Northwest Power Act, 16 USC § 839c(b)(7). PNGC Power directly purchases wholesale power and transmission services from BPA to meet the requirements of its sixteen (16) distribution cooperative members. The rates at which such power and transmission services are procured from BPA are set by BPA in its rate proceedings. Accordingly, PNGC Power has a direct and substantial interest in this proceeding. PNGC Power’s interests will not be adequately represented by any other party.
